

**EL ARTISTA DEL DIA
(THE ARTIST OF THE DAY)**

OFFICIAL SWEEPSTAKES RULES

1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY.

2. SPONSORS: Entravision Communications Corporation (“Entravision”), located at 5700 Wilshire Blvd., Suite 250, Los Angeles, CA 90036, owner and operator of radio stations stations KDLA-FM and KDLE-FM 103.1, KYSE-FM 94.7, KQRT-FM 105.1, KAIQ-FM 95.5, KLNZ-FM 103.5, KRCX-FM 99.9, KLOK-FM 99.9 and 99.5, KMIX-FM 100.9, KPVW-FM 107.1 and 104.3, KXPK-FM 96.5, KMXX-FM 99.3, KRNV-FM 102.1, and producer of *El Flaco y su Pandilla morning show*, (hereinafter referred collectively as the “Station” together with the “Station” are the “Sponsor”). HOW TO ENTER: On the first date of the Sweepstakes, in the last hour of the show “El Flaco y su Pandilla”, broadcasted Monday through Friday from 5:00 am to 10:00 am pacific time, listeners will be told the winning Artist of the Day for the next show day. Upon hearing a song of the Artist of the Day in the El Flaco y su Pandilla show, listeners need to call the Show and caller #10 to the toll free number 1-888-874-2656 will instantly win \$500.00 (Five Hundred Dollars). Calls will be selected in the order they are received. Online radio streaming might have an audio delay and might reduce the possibilities for participants to call on a timely manner.

6. PRIZES: Each winner will receive each a Prize of \$500.00 (Five Hundred Dollars) payable via check or gift card (the “Prize”). Each winner will receive his/her Prize via certified mailed. A list of prizewinners is available by mail upon written

7. HOW PRIZES ARE AWARDED: When a song by the Artista del Dia plays in the El Flaco y su Pandilla Show, caller #10 to 1-888-874-2656 instantly wins \$500.00 (five hundred dollars). There may be multiple songs aired daily of the Artista del Dia during the El Flaco y su Pandilla Show. The odds of winning depend on the number of calls received, and being the tenth caller. There is no limit to how many times a listener can win. Participants must provide legal proof of eligibility at time of entry. Eligibility requirements are set forth below.
