

**EL DOBLE TRANCAZO DEL DIA CON EL RATON
(EL RATON DOUBLE PLAY OF THE DAY)**

OFFICIAL SWEEPSTAKES RULES

1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY.

2. 5. HOW TO ENTER: “El Show del Raton”, broadcasted Monday through Friday from 5:00 am to 10:00 am pacific time, once per program, will air two songs back to back by the same artist. Calls will be selected in the order they are received. If two songs of the same artist play sequentially with a station identification between the songs, it is not an entry point. The qualifying songs must air in their entirety back to back by the same artist with no separation. Online radio streaming might have an audio delay and might reduce the possibilities for participants to call on a timely manner.

HOW PRIZES ARE AWARDED: Upon hearing two songs of the same artist back to back in the El Show del Raton program, listeners need to call the Show and caller #10 to the toll free number 1-888-874-2656 will instantly win \$1000.00 (One Thousand Dollars). Calls will be selected in the order they are received. If two songs of the same artist play sequentially with a station identification between the songs, it is not an entry point. The qualifying songs must air in their entirety back to back by the same artist with no separation. The odds of winning depend on the number of calls received, and being the tenth caller. There is no limit to how many times a listener can win. Participants must provide legal proof of eligibility at time of entry. Eligibility requirements are set forth below.
